At Rockdale Medical Center,

our goal is to deliver the best healthcare available to the residents of Rockdale and surrounding counties, as we seek to make our community healthier. With the help of dedicated physicians, employees, volunteers and board members, along with your support and encouragement, we continue our passionate pursuit of excellence.

Being a for-profit, taxpaying hospital does not diminish the amount of charitable care we provide to the community. In fact, delivering quality healthcare to all the residents of our community close to home is

the single most important contribution we make. But there are many other ways we make a positive impact on the communities we serve. Here are a few of the ways we are making a difference.

Nearly \$5.7 million spent in 2014

In 2014, Rockdale Medical Center invested nearly \$5.7 in capital improvements. These expenditures support the mission and vision of the hospital in meeting the healthcare needs of our community. Significant funds were invested in our imaging (radiology) department to ensure that RMC continues to offer state of the art technologies, including replacement of an MRI unit and nuclear medicine camera replacement, as well as adding digital mobile X-ray equipment and software technologies that allow for enhanced reporting. Significant upgrades were made in the surgical services arena, including updating our endoscopy systems, scopes and the purchase of new equipment to allow the hospital to offer new services to our community. Specifically, RMC purchased endoscopic ultrasound equipment to be able to offer advanced endoscopy services to aid our physicians in the diagnosis and treatment of gastrointestinal diseases. Numerous other pieces of surgical equipment were made available to support a growing number of surgical specialists capable of advanced surgical offerings, i.e. hip arthroplasty. Investments in patient beds, stretchers, and other clinical monitoring equipment were made to update and expand aging equipment. Together these improvements cost more than \$4.5 million.

Finally, significant additional dollars were spent to improve the facilities infrastructure, including upgrades for our kitchen and food

preparation areas, replacement of several sections of the hospital's roof, rebuilding of a large air handling unit and enhancements to our backup generators. These infrastructure improvements accounted for an additional \$504,000.

In fact, we invested \$5,672,914 in our facility in calendar year 2014, which, in addition to the above, included technology replacement, information technology additions/updates, and important facility upkeep and maintenance.

Contributing to our local tax base

While some non-profit hospitals must rely on tax support from the community, Rockdale Medical Center supports the community through the taxes we pay.

Last year, Rockdale Medical Center paid more than \$3.2 million in taxes which helped support our city, county and state. This included sales taxes as well as property taxes. These dollars help maintain local schools, fund the development of roads and provide other similar services vital to support and sustain a thriving economy.

Helping those in need

Rockdale Medical Center is committed to ensuring the delivery of needed healthcare to all members of the community, regardless of ability to pay. Last year, the cost to Rockdale Medical Center was nearly \$9.2 million to provide services for those without the ability to pay for their care.

Adding new physicians

During the past year, Rockdale Medical Center added 24 new physicians to our highly respected medical staff, including specialists in breast surgery, cardiology, gastroenterology, general surgery, gynecology, hematology/oncology, hospital medicine, nephrology, neurology, orthopedic surgery and pediatrics.

One of our community's major employers

With an annual payroll of \$68,973,801 and an average of 1,257 employees, Rockdale Medical Center is one of the largest employers in the region. This means that our staff and family members attend many of the same schools, shop at the same stores and volunteer their time and resources for the same organizations as you do.
